**PROPOSED RENOUNCEABLE NON-UNDERWRITTEN RIGHTS ISSUE  
– RECEIPT OF IN-PRINCIPLE APPROVAL FROM THE SGX-ST**

---

**1. INTRODUCTION**

The board of directors (the "**Board**" or the "**Directors**") of Leader Environmental Technologies Limited (the "**Company**", and together with its subsidiaries, the "**Group**") refers to the announcements made by the Company on 26 April 2021 and 3 May 2021 (the "**Rights Issue Announcement**") in relation to, *inter alia*, the proposed renounceable non-underwritten rights issue (the "**Rights Issue**") of up to 663,488,100 new ordinary shares in the capital of the Company (the "**Rights Shares**") at an issue price of S\$0.10 for each Rights Share, on the basis of one (1) Rights Share for every two (2) existing ordinary shares in the capital of the Company. Unless otherwise defined, all capitalised terms used in this announcement shall bear the same meaning as ascribed to them in the Rights Issue Announcement.

**2. RECEIPT OF IN-PRINCIPLE APPROVAL**

Further to the Rights Issue Announcement, the Board wishes to announce that the Singapore Exchange Securities Trading Limited (the "**SGX-ST**") has on 24 June 2021 granted its in-principle approval for the listing of and quotation for up to 663,488,100 Rights Shares on the SGX-ST pursuant to the Rights Issue, subject to the following:

- (a) compliance with the SGX-ST's listing requirements;
- (b) a written undertaking from the Company that it will comply with Rules 704(30) and 1207(20) of the Listing Manual in relation to the use of the proceeds from the Rights Issue and where proceeds are to be used for working capital purposes, the Company will disclose a breakdown with specific details on the use of proceeds for working capital in the Company's announcements on use of proceeds and in the annual report;
- (c) a written undertaking from the Company that it will comply with Rule 877(10) of the Listing Manual with regard to the allotment of any excess Rights Shares; and
- (d) a written confirmation from financial institution(s) as required under Rule 877(9) that the Undertaking Shareholder who has given the Deed of Undertaking<sup>1</sup> has sufficient financial resources to fulfil his obligations under the Deed of Undertaking.

<sup>1</sup> As at the date of this announcement, the Undertaking Shareholder, has a direct interest in 209,853,000 Shares, representing approximately 15.81% of the Existing Issued Share Capital. The Undertaking Shareholder has provided supplemental deeds of undertaking dated 10 May 2021 and 7 June 2021 to the Company pursuant to which he has irrevocably undertaken to, *inter alia*, (i) subscribe and pay for in full at the Issue Price, an aggregate of 104,926,500 Rights Shares which will be provisionally allotted to him and (ii) to ensure that none of the Shares in which he currently has an interest (directly or indirectly) are sold, transferred or otherwise disposed of on or prior to the Record Date.

The Company has provided the written undertakings and confirmations referred to in subparagraphs (b) and (c) above to the SGX-ST.

The in-principle approval granted by the SGX-ST for the admission of, listing of and quotation for the Rights Shares is not to be taken as an indication of the merits of the Rights Issue, the Rights Shares, the Company and/or its subsidiaries.
